PRIVACY NOTIFICATION

2.) Automatically Generated Information

This also happens with respect to automatically generated information about how you use the Application. Such information helps us better understand how the Application is used and tailor services to your needs as a user.

3. Purposes of Processing Personal Data

Purposes

The Parties process Personal Data for the following purposes:
